Why is International Travel Important?

- Represents 7% of all exports for the United States.
- Largest services sector export - \$134 billion or 25% of services.
- Third-largest merchandise/services export category.
- Generated a trade surplus of \$32 billion.
- Supported 1.2 million jobs.
- International visitation represents 4% of travelers, but 17% of traveler spending, payroll, employment and taxes.

2010 International Visitation Sets New Record to Support the National Export Initiative

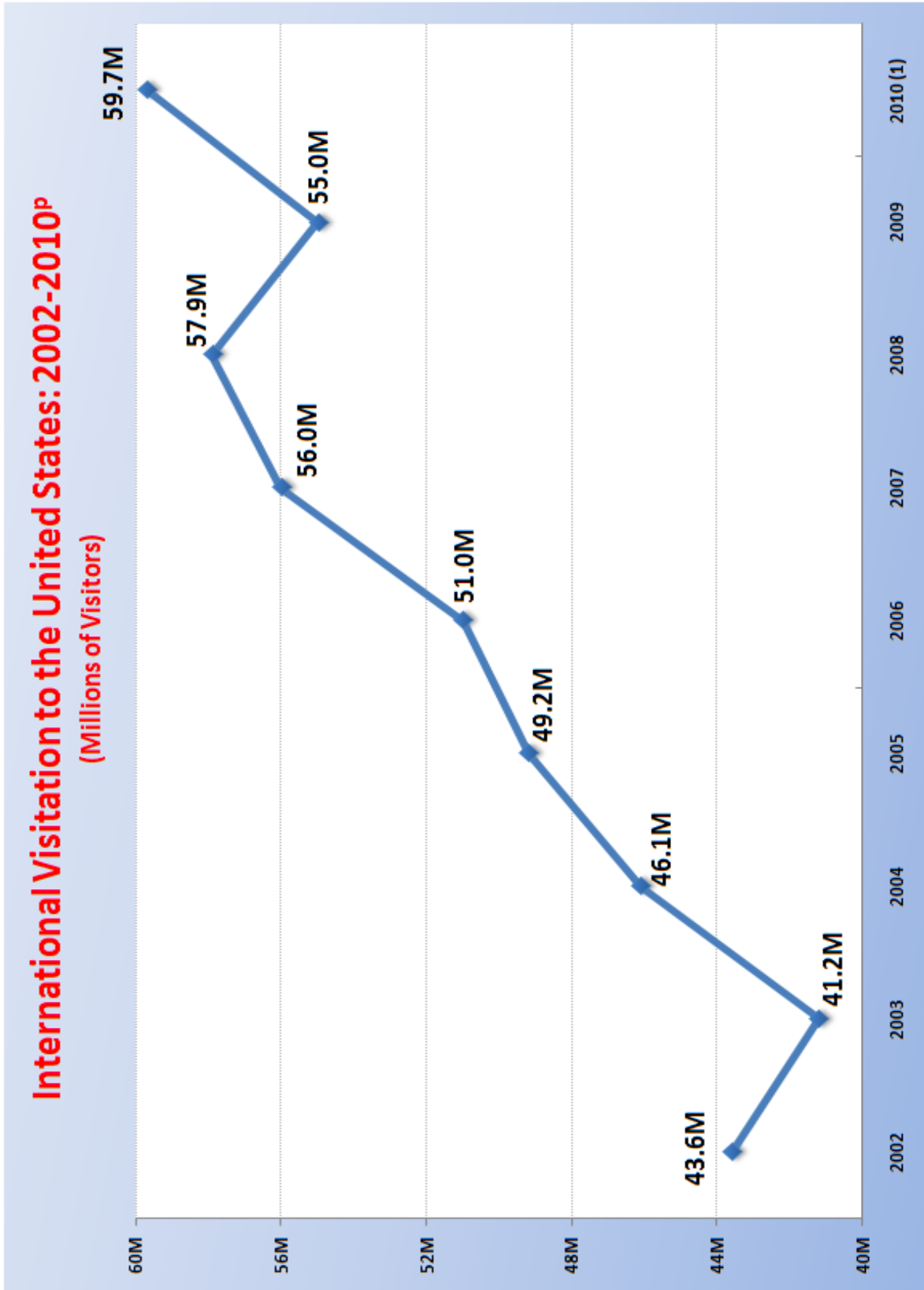
2010 was a very good year for the travel and tourism industry. The United States welcomed 60 million international visitors in 2010, a record level of visitors to the United States, 5 million more than the year before. In 2010, the top inbound markets continued to be Canada and Mexico, both of which were up in arrivals along with eight of the nine overseas regional markets. Asia, South America, Oceania and the Middle East experienced the strongest growth in 2010, due in part to record level non-resident visits to the United States from Brazil, South Korea, Australia, China, India and Colombia. Non-resident visits from Canada, which set a record in 2010, and Mexico were up 11 percent and one percent, respectively. Four regional markets brought in record levels of visitors to the United States in 2010: South America, Oceania, Middle East and Africa.

Annual overseas arrivals (excluding Canada and Mexico) totaled 26.4 million during 2010, up 11 percent from 2009. In 2010, travel from overseas markets accounted for 44 percent of total arrivals to the United States. Overseas travel was up one percent from its peak in 2000, creating a new record level of overseas visits for the United States. Seventeen of the top 50 overseas markets set new visitation records in 2010.



In 2010, 17 of the top 20 inbound visitor markets posted increases, with 13 accounting for double-digit increases. The United Kingdom, Venezuela and Ireland were the only three markets which experienced declines for the year. The top 20 visitor markets accounted for 89 percent of all international arrivals to the United States and as a group it was up nine percent compared to 2009 and grew a hefty 19 percent over its 2000 level.

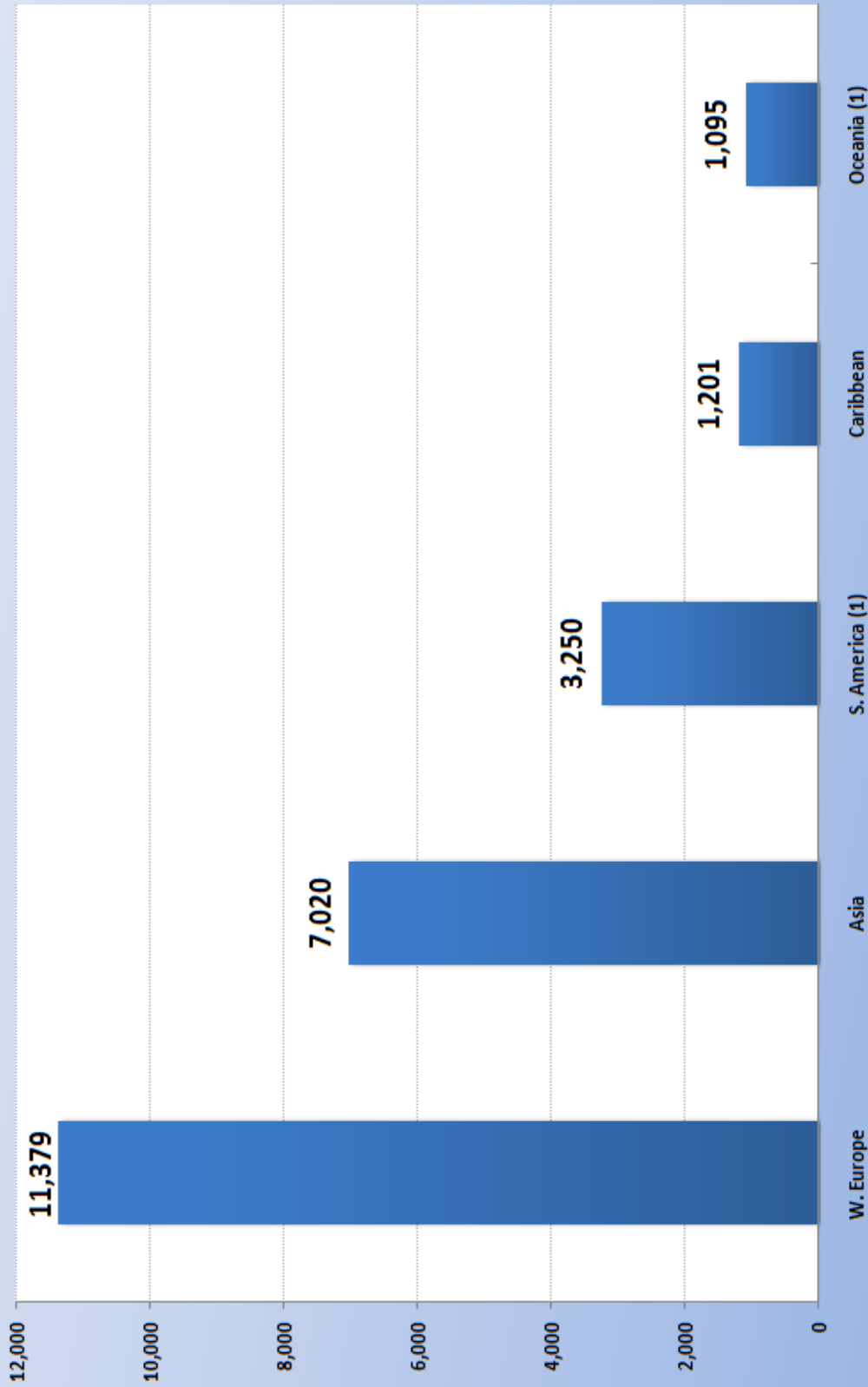

Top Five Overseas Regions for Visitation to the United States in 2010 (Thousands of Visitors)



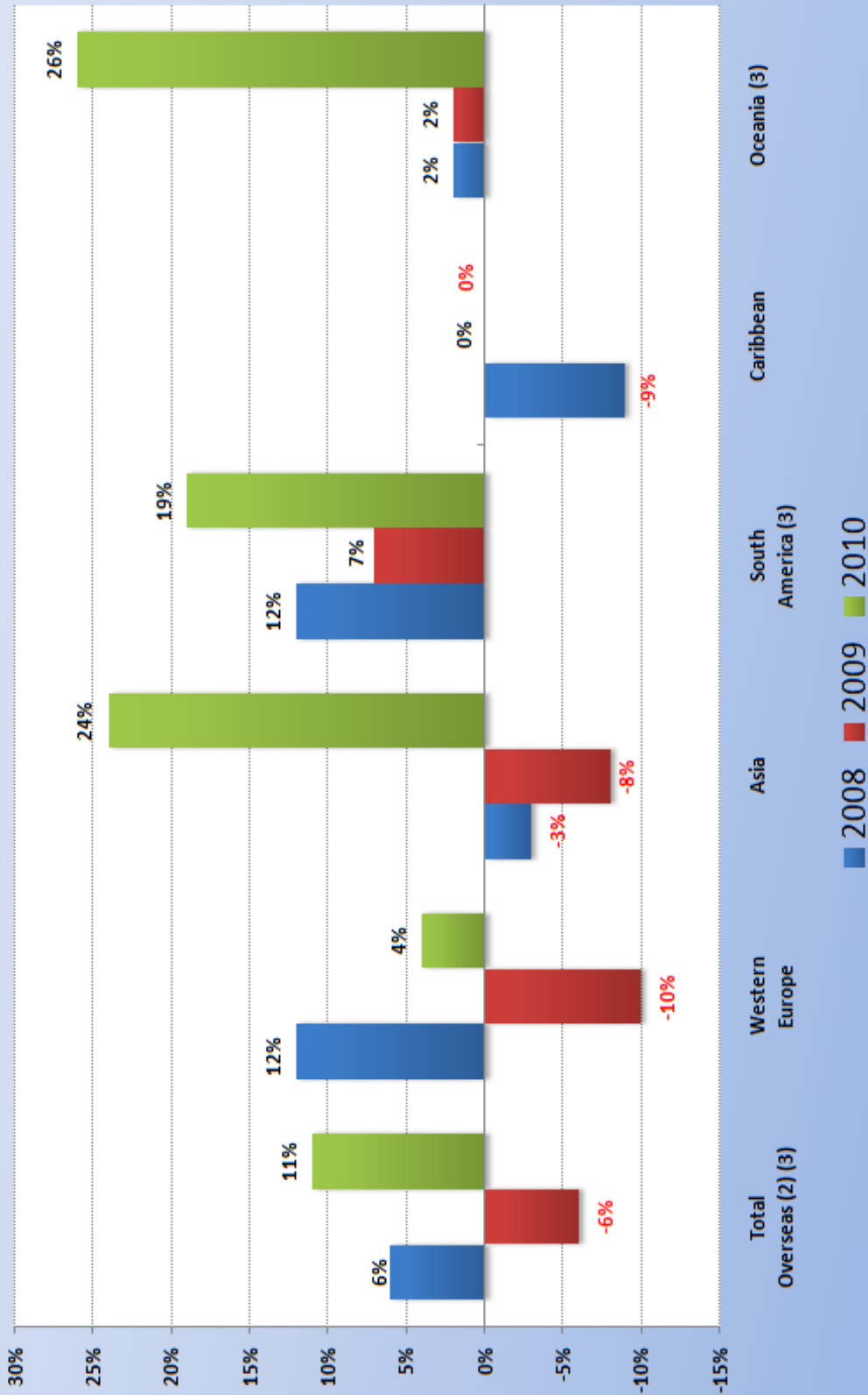

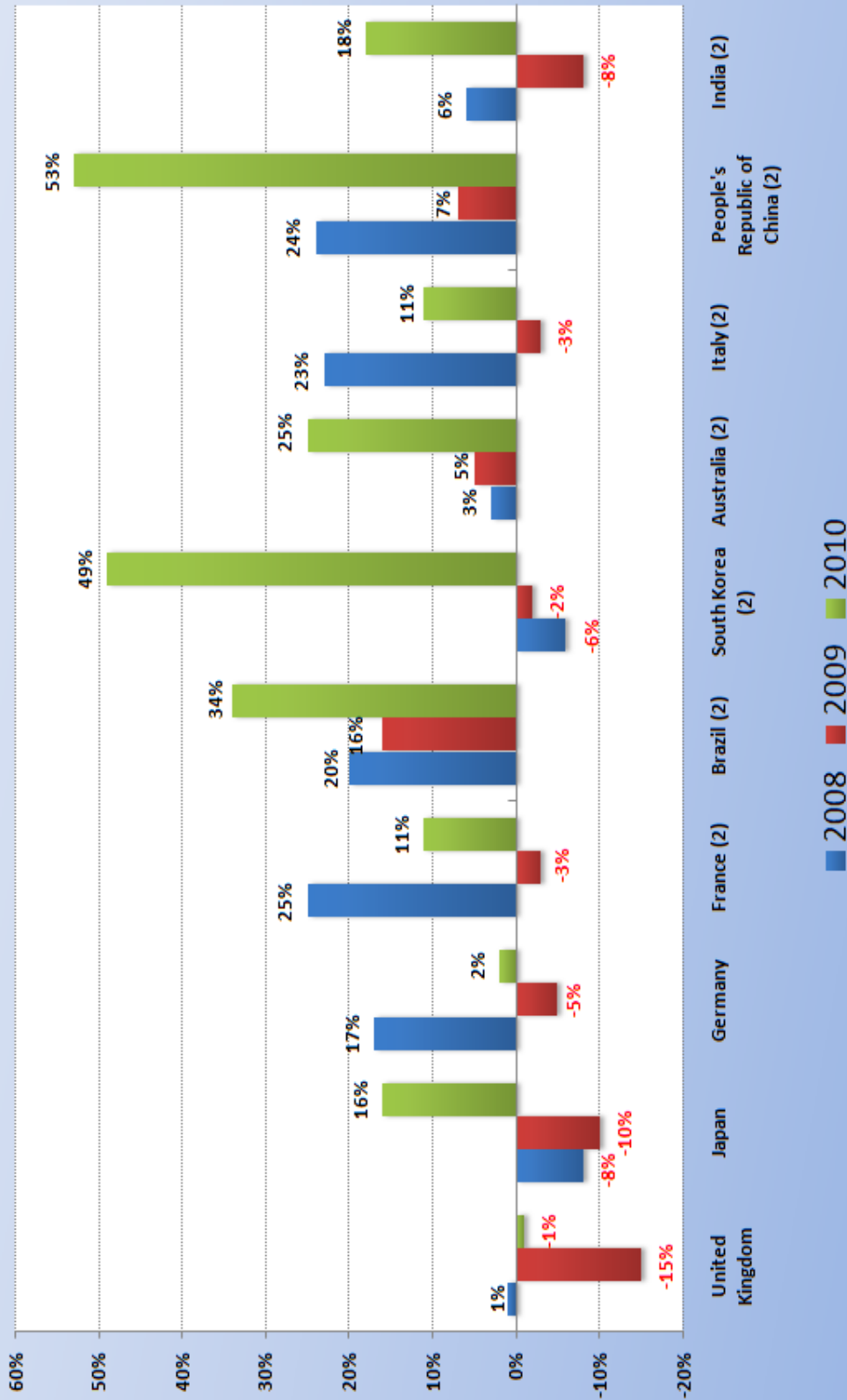

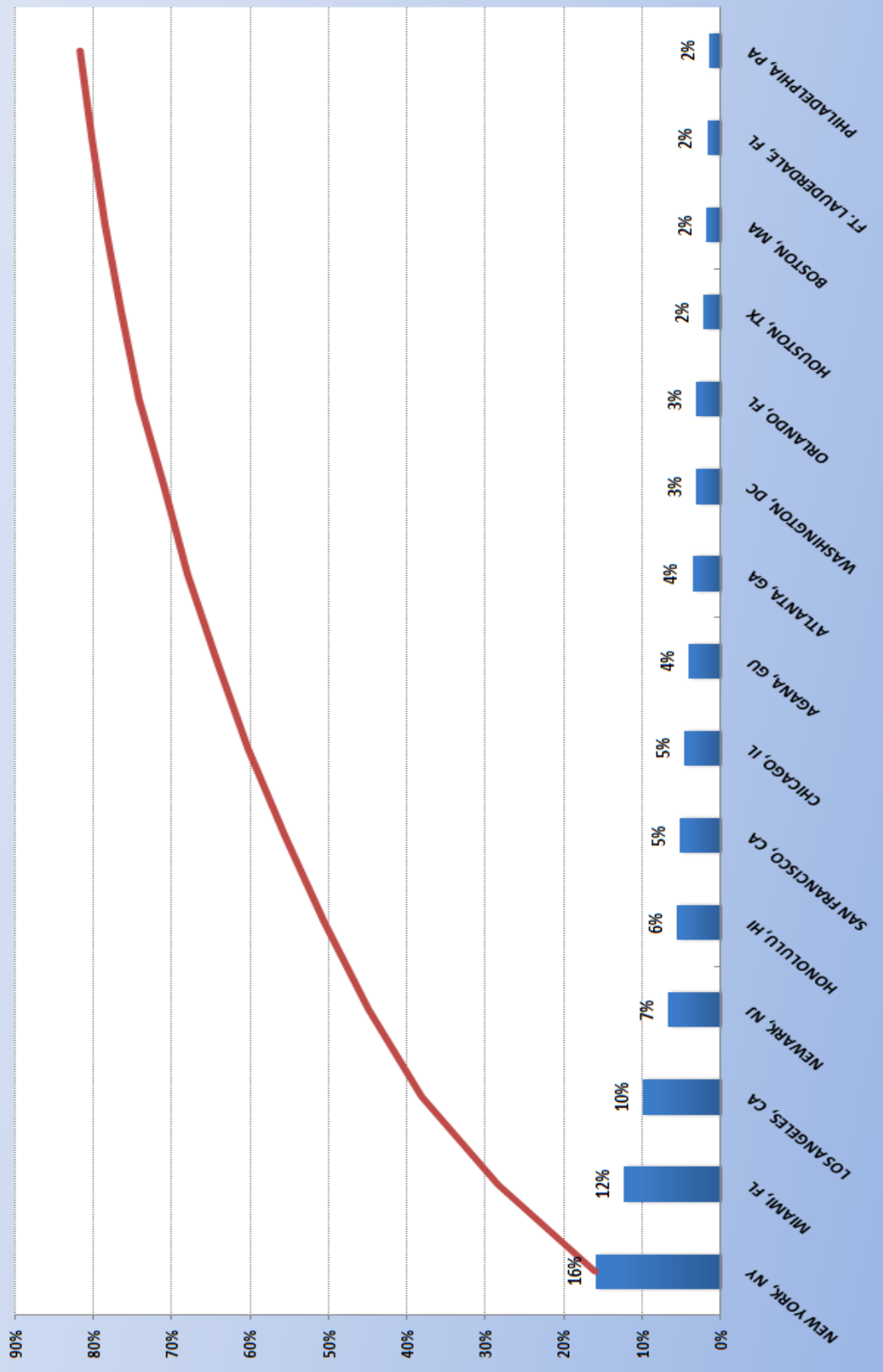
